

ANNUAL GENERAL MEMBERSHIP MEETING!

We have a lot of business to discuss including changes to the By-Laws and the Policies/Constitution. Additionally, elections will take place for Officers. Please be sure to attend so we have a quorum to discuss and vote on these important issues!

NOTICE

The following states have elections for Representatives and Alternates this year! As per our By-Laws:

- A. Election: State Representatives are elected by the member's own state for a two (2) year term:
 - Representatives may be elected prior to the Annual Membership Meeting by N.J.A.
 members in their state by the majority vote of that state's members providing that all N.J.A.
 members of that state or government entity are properly notified of the time, place and
 date of the election;
 - a) If the state's or government entity's members agree, the Representative shall arrange for the election to take place in the state or governmental entity;



- b) The Delegation from each state of government entity with an impending vacancy on the Council of State Representatives shall submit to the Chairperson of the Nomination Commmittee the names of the member elected by their prospective state or government entity to their State Representative;
- c) A Regular Member of the nominee's state or government entity may challenge the election and the dispute shall be referred to that state's or government entity's delegation for settlement.

EXCITEMENT AWAY FROM THE BENCH!

In November, I had the opportunity to take an 18-day service program trip to India as part of a group of ten women. Our leader, Rep. Michelle Bos-Lun, is a woman I served with in the Vermont Legislature. The trip was organized by Bihar Education Change (BE Change-www.bechangefoundation.org), which is a non-profit organization that funds projects in rural primary schools in Bihar Province, the poorest province in India. We flew into Delhi and did some sightseeing for a day or two as we adjusted to jet lag, which included the Gandhi Museum, the India Gate, and the Lodi Garden.

We were supposed to fly to Dharamshala, but planes were grounded due to the intense smog. A small bus was conjured up and we set out for what was supposed to be a ten-hour drive but turned out to be fourteen. We arrived in Dharamshala at 1:30 AM, unloaded the bus, and caught a few hours of sleep before getting up early to walk to the Dalai Lama's Temple. Meeting His Holiness the Dalai Lama, was an awesome, moving experience.

Our time in Dharamshala was spent learning about the Tibetan refugee experience, including visits to the Tibetan Handicraft Center, an elementary school for refugee children, and a bead factory where women are taught the art of lampwicking that gives them a skill, to deter them from being lured into the sex trade. Our afternoons were spent tutoring Buddhist monks in English, which they called the "universal language." We spent a day "off" hiking up to Bhagsu Falls and meeting with an American Buddhist nun. The government of Tibet (in exile) is in Dharamshala and a visit to the government buildings, including their Judiciary, was very interesting.

Dharamshala is in the foothills of the Himalayas; the terrain is very hilly, and I got plenty of exercise walking to all of our activities. Life there is much different. For two weeks, I ate a vegetarian diet and became very fond of turmeric lattes and mango lassi. It is not recommended to consume meat or poultry. When eating, you always use your right hand. It is also necessary to purify all drinking water, unless you buy bottled mineral water. Toilet paper is a luxury offered by the guest houses we stayed at but not at general public bathrooms, so one needs to go prepared.

We then flew to Bodh Gaya, which is a more agricultural area, in fact, almost every square inch is in cultivation with rice and vegetables. Our guest house was a yoga ashram, run by an Indian man and his Japanese wife. Across a small courtyard is the Prema Metta School and Orphanage, which BE Change supports. The children come to school in uniforms, are eager to learn, and seem to know that education is

very important to break the cycle of poverty. We also visited Bhavishya Me Free Education School and Kamal School in a much more rural location. The children were also eager to learn, but some were clothed poorly, which broke my heart. The associated Kamal School is a place where women learn how to sew so they can help provide a living for their families.

BE Change sponsored the construction of the kitchens at both schools and provides daily lunches for the children. We ate with the children at Bhavishya Me School, which involved eating only with our right hands (no utensils) and sitting on the floor. Yes, I was able to get back up without help!! Each child



gets a heaping plate of rice with dal and aloo gobi (potato and cauliflower). It was impressive to see the kids eat every morsel on their plates.

Everything in India gets used. I watched a woman mixing cow dung and rice straw to make patties that are flattened into 6–7-inch rounds and stuck to the sides of buildings, trees, and walls. When dry, they are used for fuel. When cauliflower is harvested, the head is used to feed humans, the leaves go to the cattle, the stalks are used for broth, and the roots are dried for fuel.

Eighty percent of Indian rice production is done by hand. All day, you will see people out in the fields gathering and wrapping dried rice into sheaves, which are then stacked into huge bales and loaded onto workers' backs. Threshing may be done by machine or by hand, which is intense work.

Bodh Gaya is also the place where the Buddha experienced enlightenment, so there are many people making pilgrimages at temples of different nationalities. We were able to visit the famous temple with the great-granddaughter of the original Bodhi tree where the Buddha was enlightened.

Our final day was spent in Agra at the Taj Mahal. It is hard to verbalize how beautiful and amazing this perfectly symmetrical building is, which seems to float in the morning mist. It is a must see if you are in India.

India overwhelms the senses with color, noise, smells, horns, begging people, cows, and dogs. It took me a day or two to get used to the cacophony of Dharashala, but I found it ultimately beautiful. While not always easy, this trip was transformative and enlightening. What sticks with me most is a quote from His Holiness the Dalai Lama – "If you want others to be happy, practice compassion. If you want to be happy, practice compassion."

Do not hesitate to reach out to me if you have any questions, concerns, news, photos, etc. I love to hear from you all!


